# **JURISDICTION**

- Plaintiff, State of Ohio, by and through counsel, the Attorney General of Ohio, Dave Yost, having reasonable cause to believe that violations of Ohio's consumer protection laws have occurred, brings this action in the public interest and on behalf of the State of Ohio under the authority vested in him by the Ohio Consumer Sales Practices Act ("CSPA"), R.C. 1345.01 *et seq.*, and the Certificate of Motor Vehicle Title Act, R.C. 4505.01 *et seq.*
- 2. The actions of Defendants Eastpoint Car Brokers LLC and Kimberly Godfrey ("Defendants"), hereinafter described, have occurred in the State of Ohio, Franklin County

and other counties, and, as set forth below, are in violation of the CSPA, R.C. 1345.01 *et seq.*, and the Certificate of Motor Vehicle Title Act, R.C. 4505.01 *et seq.* 

- Defendants, as described below, are each a "supplier" as that term is defined in R.C. 1345.01(C) as Defendants were, at all times relevant herein, engaged in the business of effecting or soliciting "consumer transactions" as that term is defined in R.C. 1345.01(A).
- 4. Defendants, as described below, engaged in "consumer transactions" by offering for sale, selling or financing the purchase of used motor vehicles to individuals for purposes that were primarily personal, family or household within the meaning specified in R.C. 1345.01(A).
- The actions of Defendants, hereinafter described, have occurred in the State of Ohio and Franklin County.
- Jurisdiction over the subject matter of this action lies with this Court pursuant to R.C.
  1345.04 of the CSPA.
- 7. This Court has venue to hear this case pursuant to Ohio Civ. R. 3(C)(2) and (3), in that Defendants operated their business from and engaged in some of the transactions complained of herein in Franklin County, Ohio.

### **STATEMENT OF FACTS**

8. Eastpoint Car Brokers LLC ("Eastpoint Car") was a domestic limited liability company conducting business in Franklin County and other counties in the State of Ohio with its principal place of business located at 983 E. Main St., Columbus, Ohio 43205.

- 9. Defendant Eastpoint Car at all relevant times was a licensed used motor vehicle dealer, operating under a permit issued by the Ohio Bureau of Motor Vehicles, permit number UD021805. The permit is inactive.
- 10. On information and belief, Defendant Kimberly Godfrey is an individual whose address is 1499 Garywood Ave., Columbus, Ohio 43227.
- 11. On information and belief, Defendant Kimberly Godfrey was the principal owner of Eastpoint Car and dominated, controlled and directed the business activities and sales conduct of Eastpoint Car, exercised the authority to establish, implement or alter the policies of Eastpoint Car and committed, allowed, directed, ratified or otherwise caused the following unlawful acts to occur.
- 12. Defendants were at all times relevant to this action engaged in the business of soliciting, promoting, purchasing, selling, financing and collecting the proceeds of the sales of used motor vehicles to consumers residing in Franklin and other Ohio counties.
- 13. Defendants, operating under the name Eastpoint Auto Brokers LLC, solicited individual consumers to enter into consumer transactions, specifically for the sale of used motor vehicles.
- 14. Defendants solicited Ohio consumers for the sale of motor vehicles, and engaged in acts and practices that violated the CSPA, R.C. 1345.01 et seq., and the Certificate of Motor Vehicle Title Act, R.C. 4505.01 et seq.
- 15. The Defendants failed to file applications for certificates of title within thirty days after the assignment or delivery of motor vehicles.
- 16. The Defendants failed to obtain certificates of title on or before the fortieth day after the 3

sale of motor vehicles.

- 17. Title Defect Recision ("TDR") consumer claims totaling Seventeen Thousand Five Hundred Thirty-Five Dollars thus far was paid from the TDR Fund, administered by the Ohio Attorney General's Office, after the Defendants failed to obtain certificates of title on or before the Fortieth (40th) day after the sale of the motor vehicles.
- 18. After payment was made from the TDR Fund, the Defendants continued to do business and failed to obtain a surety bond in violation of R.C. 4505.181, which requires that a dealer post a surety bond in an amount not less than \$25,000.00 after the Attorney General has paid a retail purchaser of the dealer from the TDR Fund.

# <u>CAUSE OF ACTION</u> <u>VIOLATIONS OF THE CONSUMER SALES PRACTICES ACT</u>

- Plaintiff incorporates by reference, as if completely rewritten herein, the allegations set forth in paragraphs One through Eighteen (1-18) of this Complaint.
- 20. The Defendants engaged in unfair and deceptive acts and practices in violation of R.C. 1345.02(A) by failing to file applications for certificates of title within thirty days after the assignment or delivery of motor vehicles as required by R.C. 4505.06(A)(5)(b).
- 21. The Defendants engaged in unfair and deceptive acts and practices in violation of R.C. 1345.02(A), by selling motor vehicles to consumers, in the ordinary course of business, and then failing to obtain certificates of title on or before the fortieth day of sale of the motor vehicles as required by R.C. 4505.181(B)(1).
- 22. The Defendants continued to do business and failed to post a surety bond after the Attorney General paid a retail purchaser of the dealer from the TDR Fund due to the Defendants'

failure to deliver title to the purchaser, as required by R.C. 4505.181.

Such acts or practices have been previously determined by Ohio courts to violate the CSPA,
 R.C. 1345.01 *et seq*. The Defendants committed said violations after such decisions were available for public inspection pursuant to R.C. 1345.05(A)(3).

#### PRAYER FOR RELIEF

WHEREFORE, Plaintiff respectfully prays that this Court:

- A. ISSUE A DECLARATORY JUDGMENT declaring that each act or practice described in Plaintiff's Complaint violates the CSPA, R.C. 1345.01 *et seq.*, and the Certificate of Motor Vehicle Title Act, R.C. 4505.01 *et seq.* in the manner set forth in this Complaint.
- B. ISSUE PERMANENT INJUNCTIVE RELIEF enjoining Defendants and any officers, agents, representatives, salespeople, employees, successors and assigns and all persons acting in concert or participating with them, directly or indirectly, from engaging in the acts and practices of which Plaintiff complains and from further violating the CSPA, R.C. 1345.01 *et seq.*, and the Certificate of Motor Vehicle Title Act, R.C. 4505.01 *et seq.*
- C. ORDER Defendants liable for reimbursement to all consumers found to have been damaged by the Defendants' unfair and deceptive acts and practices, and motor vehicle title violations.
- D. ORDER Defendants liable for reimbursement to the TDR Fund for money expended to resolve title defects caused by Defendants' motor vehicle title violations.
- E. ASSESS, FINE, AND IMPOSE upon Defendants a civil penalty of \$25,000.00 for each of the appropriate unfair and deceptive acts alleged in the Complaint, pursuant to R.C. 1345.07(D).

- F. ORDER that the Defendants be enjoined from engaging in consumer transactions as a Supplier in the State of Ohio until they have satisfied all restitution, civil penalties, court costs, reimbursed the TDR Fund and have posted the required R.C. 4505.181 surety.
- G. ORDER that the Defendants be prohibited from maintaining, renewing or applying for an auto dealer or salesperson license under Chapter 4517 of the Revised Code.
- H. GRANT Plaintiff its costs in bringing this action, including, but not limited to, the costs of collecting on any judgment awarded.
- I. ORDER the Defendants to pay all court costs.
- J. GRANT such other relief as the Court deems to be just, equitable and appropriate.
